Minutes

1. Welcome

JB welcomed everyone to the meeting.

2. Introductions

- JB asked everyone to introduce themselves.
- SJ ran through what the Bat and Ball Residents Association is and what he expects to get out of attending the Steering Group meetings.

3. Approval of minutes

4. Actions from the last meeting

5. Update on project timescales

A) Section 106 agreement – verbal update

 JC gave an update on where Tarmac is with the S106 agreement, stating that the final comments from the council will be sent in the next few weeks.

B) Timeline

- MC asked if Tarmac wanted to be involved with Sevenoaks Town Council's Sports and Leisure Strategy. MK said that Tarmac would happily be involved.

A) Scout Barn

B) Oast House

- JB updated members on where everything is with the Oast House, stating that a
 meeting was held between STC and Tarmac where STC outlined what they would like to
 see happen with the Oast House a flexible, community use.
- MK stated that Tarmac are currently working on the structural issues so that the building is sound, at which points plans for the building could then be progressed.

 JB updated the Steering Group on the local engagement that had been undertaken such as placing adverts in both the Sevenoaks Crier and Seal Parish Advertiser and attending the Sevenoaks Town Council Annual Assembly, with plans to attend Seal Parish Council's Annual Assembly in May.
